 - c. Acknowledgement and approval of the exchange by both universities.
 - d. It is the responsibility of the home university to determine the acceptability of the course offerings and the validity of credit transfer to the student's home university.
 - e. The learning agreement shall be signed by the student, and signed by appropriate representatives of the home university (stamped with the university seal), and the host university (stamped with the university seal).
- 16. Transcripts the host university will provide the transcript of the exchange student's study results within 21 days of the last day of the semester attended by the student.
- 17. Housing placement: the universities shall provide information, advice, and assistance to the exchange student regarding housing accommodation.
