This Memorandum of Agreement (MoA) is made on this day 23rd March 2018

Between

Christ Institute of Management Rajkot an institution of higher learning established in Rajkot India, whose address is at Saurashtra University, Rajkot, Gujarat 360005, India and shall include its lawful representatives and permitted assigns of the first part;

And

Universitas Wijaya Kusuma Surabaya, a well established private university in Surabaya Indonesia (hereinafter referred to as "**UWKS**"), whose address is at Jl. Dukuh Kupang XXV / 54 Surabaya, East Java, Indonesia and shall include its lawful representatives and permitted assigns of the second part;

The Two Parties agree to cooperate in the development of academic and research which further this goal. Both the Parties have understood and concluded the following:

COLLABORATION ON INTERNATIONAL CONFERENCE AND SEMINARS

- Article 1 : Both Parties have been organizing the 3rd International Conference on Emerging Global Trends In Humanities, Science, Technology, Commerce and Management Education which will be held on 23 and 24 March 2018 in Christ Institute of Management, Rajkot, India.
- Article 2 : Both parties will organize conferences, seminars and courses in the International conference as stated in article 1 annually and will exchange literature and information based on mutual interests.
- Article 3 : Universitas Wijaya Kusuma Surabaya Indonesia will take a chance to hold a university promotion in the area of 3rd International Conference on Emerging Global Trends in Humanities, Science, Technology, Commerce and Management Education on 23 and 24 March 2018 in Christ Institute of Management, Rajkot, India.

APPLICATION:

Article 4 : Any other activities describing the cooperation of Two Parties will be defined and negotiated when necessary and Both Parties agree to put in a written document in advance before commencing the activities.

VALIDITY:

Article 5 : This Memorandum will come into force after the approval of *The Institute Body of Christ Institute of Management Rajkot and Wijaya Kusuma Foundation* and will remain in effect for a period of five (5) years after which it may be renewed.



Article 6 : Either Party may terminate this Memorandum by officially notifying the other Party of its intent to do so in writing by registered post six (6) months in advance.

Article 7 : The provisions of this Memorandum may be amended at any time by the mutual consent in writing of Both Parties. The amendments will become part of this Memorandum.




